Privacy Policy

1. The RNIOA website is the intellectual and material property of its two founders: retired Royal Navy Instructor Officers Lt Cdr Michael Rose and Lt John Nixon. All decisions concerning future developments and the publication of new material, including service stories submitted by former Instructor Officers, will be the responsibility of its co-founders. Decisions will be made through internal discussion and consultation, where appropriate, with members of the RNIOA Advisory Panel, whose members are also free to offer suggestions for future developments where necessary.
2. The RNIOA is a nonprofit organisation and does not ask for fees to cover the running costs of the website. Contributors are invited, however, to donate to a Royal Navy Charity of our choice, which is indicated by means of a link on the submissions page (entirely optional). Any revenue generated through the sale of print publications such as books will be used, with the permission of contributing authors, to fund RNIOA running costs (not including labour) and website development, with any excess monies being donated to a suitable charity as decided by the co-founders in consultation with RNIOA contributing authors.

3. The RNIOA takes the issue of security and data protection seriously and adheres to guidelines published in the United Kingdom Data Protection Act. The RNIOA is therefore committed to ensuring that your privacy is protected.
4. We may record and store your name, email address, e-mails and postal address (if needed), after contacting us for the purposes of communication or material delivery only, and have no intention of passing these details on to third parties.
5. The RNIOA site does not use cookies, nor does it track usage of our visitors, nor store data relating to their visits, aside from the simple counting of visitors to the site, which can be observed by the counter at the foot of all of the site's pages.
6. The transmission of information via the internet (including email) is not completely secure. However, we endeavour to guarantee the security of personal data to the best of our ability. The provision of such data is entirely at your own risk.
7. If you access other websites using the links provided, the operators of these sites may collect information from you that will be used by them in accordance with their own privacy policies. We do not accept any responsibility or liability for their policies whatsoever, as we have no control over them.
8. No data transfers over the internet can be 100 per cent secure but we have taken specific steps to ensure that the data of contributors are protected as much as possible. We ask contributors to submit their stories using their own e-mail provider and attachments. We will then use a secure and advertisement-free email system for communication between us and contributors.
9. Contributors should be aware that submissions to the RNIOA, once edited and approved by the contributor, will be published on the RNIOA site and be available to the general public (with the exception of password access controls to some service stories if requested by contributors) as an educational resource. It is necessary, therefore, for contributors to not include any personal data such as address or date of birth.
10. The RNIOA cannot accept any liability for legal challenges which may arise from the content of published service-related stories. Where necessary, the RNIOA will remove stories that are found to contain information which suggests legal or confidentiality breaches may be possible.
11. Contributors are encouraged to include images that relate to their service stories or articles but it is the responsibility of contributors to ensure that all images are their own, even though some doubt may exist about who the actual copyright holder is. To protect and mitigate any copyright restrictions or challenges that may emerge, we adopt the following conventions:
 - a. For images that have been created/photographed by the donator (and therefore the copyright holder) we include, under each image, the name of the contributor, the copyright symbol, and the phrase "all rights reserved" to indicate that permission is needed from the owner to copy that image.
 - b. For images that have been taken by an unknown third party such as a colleague, department, or a ship's photographer, and acquired by the owner, the copyright is often unknown and we therefore include, below the image, the name of the donator, the term "no known copyright issues" and the phrase "all rights reserved". Here the term "no known copyright issues" indicates that the RNIOA is unaware of any copyright restrictions that have been placed on that image. However, if any issues do arise the RNIOA will investigate and take appropriate action, including removal of images if warranted.

- c. For images that are known to be in the public domain (older than 70 years from the death of their original creators) we include the term “public domain” under each image.
 - d. For images that have been located on the internet we acknowledge the source and provide a URL. Where permissions are needed to use such images on the RNIOA website the relevant individual or organisation will be contacted.
 - e. For donated images that contain individuals other than the donator, we will generally only include names for those who have provided permission.
 - f. As the RNIOA is a non-commercial, nonprofit association dealing in research and information provision, copyright law generally permits the use of the images that appear on the website. We therefore provide the following disclaimer on the gallery, service stories and articles pages: “All images that have been submitted by contributors are assumed to be for display with the permission of the copyright holder. The RNIOA will consider any copyright issues that are brought to our attention and take appropriate action if required”.
12. Contributors are free to contact the RNIOA by e-mail to either amend or remove their stories from the website. In the latter case, all electronic versions of the original story will then be deleted from RNIOA storage systems.

Work Associates of the RNIOA

1. It may be beneficial for the two co-founders to employ other former RNIOs as associates, particularly in the domain of editing, writing, and encouraging former colleagues to contribute new material for the site in the form of stories and blogs. Providing advice on the editing and improvement of other documents may also be productive areas in which associates can contribute. Honorary positions also fall under the category of associate.
2. Associates will be given a suitable title, and will receive material from the Editor when channelled through the RNIOA email account. Associates may use their RNIOA title in private email accounts they use to communicate with RNIOA contacts, and personal contacts when appropriate.
3. The length of any associate’s appointment shall be determined by mutual agreement between an associate and the two co-founders. The co-founders have the sole and exclusive right to begin or end associate appointments according to work requirements, or any other related matters.
4. Associates must, at all times, conduct their work in full compliance with the RNIOA’s site policies, as outlined in all sections of this document (see above). Particular attention should be paid to ensuring the privacy of RNIOA contacts and no information (such as email addresses) should be passed to third parties without the permission of the individual concerned. When editing, associates should take particular care in terms of screening out any (current) personal details included in service stories and blogs.
5. Associates will usually be asked to undertake projects by one of the two co-founders, but they should also feel free to propose projects and work under their own creative initiative when appropriate, channelling material and project proposals through the co-founders.
6. The two co-founders will retain final editorial and publishing control of all material to be included on the RNIOA website, removed from the site, or edited.

7. As the RNIOA is a nonprofit entity, associates will work as unpaid volunteers consistent with those of the two co-founders.
8. The two co-founders or the RNIOA cannot be held accountable for any independent actions of associates that lead to legal action being taken against associates.
